# I. NATIONAL: " A CHILD'S VIEW OF PEACE . . . AND WAR."

THE BL.

"It would be a color FILM, 16 mm. in both English and French, suitable for showing to all manner of groups of all ages, 18-20 min. in length. Distribution prints would be available at minimum cost.

The total amount required for making the Film would be around \$50,000.

Evelyn Cherry, well-known as one of Canada's top producers of educational and documentary films would be in charge. She has applied to Canada Council for a grant of \$25,000. Applications for grants have been made to the I.Y.C. Commission by VOW groups in Regina, (Ev.'s home and where she is a VOW member) Victoria, Calgary, Toronto, Montreal, Halifax, and by National VOW." (taken from Minutes of March meeting of the B.C. Executive.)

Since then, all VOW requests for I.Y.C. funding have been turned down by the Commission for no stated reason. Because the Commission is believed to have been overly cautious in alloting funds to date, a request has gone forward from the Co-ordinator that it reconsider its decision. Canada Council's reply to E. Cherry's application is not known yet. In view of the contribution to Canadian life which has been made by members of The Voice of Women/ Ia Voix des Femmes during the past 20 years and in consideration of the value of such a topical film, it would be strange should VOW not be considered as worthy of public moneys in The International Year of the Child.

In order to be eligible for a Canada Council Grant and for promised contributions from The Canadian Friends Service Committee, Saskatchewan I.Y.C. Commission and some others - all on a dollar for dollar matching basis, VOW IYC PROJECT NEEDS AN IMMEDIATE \$15,000 IN ITS TRUST ACCOUNT.(e.g. 15 @ 1000 = 15,000)

All Members and many Friends of VOW received copies of the Petition in support of the Viet Appeal in the Spring of 1979. Many were returned complete with 20 Signatures each. Thanks to all of you. At present 1500 names have been added to the Petition, 1000 of which were presented to Premier Bennett at the end of June. According to News Reports on Radio, the Premier has denied the Appeal and the Petitioners.

The Petitioning will continue. Most people are shocked and surprised to be reminded that the gesture of generosity made by our Parliamentary Representatives in 1973, remains in 1979 an empty gesture. They are happy to be given an opportunity to express their concern by signing their names to the Appeal. One hears remarks like, "They shouldn't be allowed to get away with broken promises."

Quite aside from the great suffering of children in Vietnam and many other parts of the world and quite aside from our responsibility to help the innocent sufferers, especially in The International Year of the Child, this matter can be viewed as a test of Integrity, of the honesty of our Government and of ourselves as residents of British COlumbia who value our good name at home and abroad. As Grace McCarthy, Minister of Human Resources, wrote recently in another context, "We should serve as examples to our youth, especially in the International Year of the Child."

If Newsletter readers wish to help to continue this Project, they could write to Editors of Community Newspapers, expressing their concern, and informing other people about the Appeal and the Petition. Perhaps your local Editor would publish the Appeal and add a few lines below it for signatures, which could then be clipped out and sent to Premier Bennett. (Or use the sample letter enclosed here.)

At the Sri Lanka World Symposium, attended by Alice Coppard in December, one of the Resolutions adopted states, "When 25 Nations accept the concept of World Citizenship, then the Constitution drawn up at the World Symposium will make it an accepted reality. These Nations will recognize the World Citizen Passport as valid." The Passports are now available in Esperanto, English and French to applicants of any age, from the Centre in Vancouver.

ENERGY. NUCLEAR. URANIUM.

The Bates Inquiry into Uranium Mining SHOULD be considering the safety of humans now and in future. It SHOULD be inquiring into the health of miners, the preservation of the environment and SHOULD be asking if there can be any justification at all in exploration for minerals which make possible the Nuclear Complex of Weapons and Energy. WASTE OR WORSE!

EMPHASIS SHOULD BE ON STOPPING ALL EXPLORATION FOR URANIUM UNTIL THE HEARINGS HAVE BEEN COMPLETED.

Our objective should be the total prohibition of Uranium Exploration, Uranium Mining and Uranium Use.

RESEARCH AND DEVELOPMENT FUNDS WOULD BETTER BE CHANNELED INTO RENEWABLE ENERGIES.

These are some of the thoughts reported by Lille D'Easum at recent meetings of the Executive of the B,C. Voice of Women. Lille forsaw what was to come well ahead of most people. She educated herself into becoming outstandingly knowledgable on all issues relating to Nuclear development to the point where her expertise outdoes the "experts" and she is constantly called on for materials and advice. After the process of self-education, she went on to educate many others and is still attempting to meet further requests that come daily in the mail and to her door. There must be few others in Canada who are as up to the minute and as well informed.

URANUIM, with a half-life of about  $4\frac{1}{2}$  billion years, decays first into Thorium 230, which decays into Radium, which changes into Gases called Radon daughters, including Radon-222 which when breathed into the lungs causes Cancer.

Even clearing the ground for exploration may release Radon gas into the atmosphere. The 'tailings' left behind after the extraction of Uranium are still Radio-active and remain so for millions of years. Open pit Uranium mining, tailings and the refining of Uranium Ore, constantly release Radio-active Dust and Radon Gas into the environment. This adds to the local background levels. It increases the exposure of people, vegetation, domesticated and wild animals, fish and aquatic life, to low-level radiation, depending on how close they are to the source, which way the wind blows and how much rain falls.

European scientists, who studied
Uranium Miners from Germany and
Czechoslovakia in the 1930s, showed
that by 1940, 65% of them were dying of lung Cancer. Between 1935
and 1939, 90% of Miners' deaths
were from lung cancer or lung diseases such as tuberculosis, silicosis, emphysema and chronic
bronchitis. (They were mining
Pitchblende, a native oxide of Uranium, found in pitchlike masses,
an important source of Radium.)

URANIUM WOULD BE BEST LEFT IN THE GROUND untrl and while we learn to supply necessary (not wasteful) Energy Needs from small-scale renewable sources. This calls for sanity instead of the insanity of the present headlong flight into ultimate extinction.

HUMAN RIGHTS - or the lack of them in almost all parts of the world today - must be one of the most painful and at the same time one of the most necessary considerations constantly before us. We learn about Imprisonment without trial, often for years on end, Torture of prisoners whose 'crime' is being critical of repressive regimes, Disappearances, Sudden Death, Children being beaten, maimed and killed, and we ask ourselves from our comparative safety, what can we do.

Human Rights cannot be guarded except by using those we have. Like our bodies, they tend to atrophy if not exercised. Whenever we exercise the Rights we hold and cherish, by exercising them in behalf of others, we serve ourselves also by insuring their continued existence.

Voice of Women Groups and individual members have interested themselves in many facets of Human Rights. They have spoken up, demonstrated, written, and supported those who are unequal to defending and protecting themselves, here in Canada as well as in many other parts of the world. The vanished children in Argentina is a case in point, heart-breaking to contemplate yet only one of so many more and individual cases such as that of Galindo Madrid, a young man refused Landed Immigrant status and due to be deported from Canada, probably to certain torture and death in Chile. As a result of telegrams and telephone calls to the new govt. in Ottawa, the deportation order has been temporarily delayed.

What is it like to live in a country where belonging to any political party - or even distributing leaflets for it - cuts you off from any Union position? The country is Chile where new labour repression is now making any political activity a crime. This most recent of Pinochet's repressive measures has aroused the AFL-CIO and the International Confederation of Free Trade Unions to declare a total boycott against Chile.

Chile, very recently, had a literacy rate of 90%. Today, most Chileans cannot afford to buy books. It costs \$150 a month to live marginally, but the average wage is \$30 per month. Most of Chile's population cannot afford to buy the food they produce. The military junta exports the food, some of it to Canada. Buying Chilean produce does not help its people; it strengthens the hand of the oppressor.

Ask your grocer if the apples, grapes, nectarines, pears and other fruits on the shelf are Chilean. If they are, don't buy them. We can boycott!

We can write to Members of Parliament, to the Minister of External Affairs, to the Minister of Trade and Commerce, expressing your views about Canadian trade with the Pinochet Junta and about investment such as Noranda Mines', which bolsters that anti-democratic regime.

The British Columbia Conference on the Emerging International Economic Order in Feb./79 brought together 200 delegates and resource persons from N.G.O.s, Churches, Universities, Labour, Native Indian and local community organizations. The following statement resulted:

IN ALL AREAS OF CONCERN TO THIS CONFERENCE: FOOD, TRADE, DISARMAMENT, ENERGY, ENVIRONMENT AND FINANCE, WE AGREED UNANIMOUSLY THAT THE CONCENTRATION OF CORPORATE POWER, FUNCTIONING AS ABSENTEE LANDLORDS OF WORLD ECONOMIES, IS THE GREATEST SINGLE FACTOR IN THE PROBLEMS OF SOCIAL JUSTICE AND SURVIVAL FACING CANADA AND THIRD WORLD COUNTRIES. THIS WE HAVE DECIDED ARISES FROM THE FACT THAT TRANSNATIONAL CORPORATIONS ARE NOT ACCOUNTABLE TO ANY SOCIAL MORALITY OR UNIVERSAL AUTHORITY SUCH AS THE UNITED NATIONS.

PEACE AND DISARMAMENT. There is growing participation and support by Churches in the Disarmament Movement. This is taking place, Canada-wide, as shown by Issues, past and presnet of The Ecumenical News, a paper being distributed to Church Members.

\*Operation Dismantle\* which originated in a small church office in Toronto continues to distribute barlots to individuals, asking that they mark and return them with their name and address. The Ballot is headed GLOBAL REFERENDUM and says, "I AM REQUESTING THE UNITED NATIONS TO IMPOSE TOTAL AND PERMANENT NUCLEAR DISRAMAMENT UPON ALL THE NATIONS OF EARTH, TO OFFER AN EFFECTIVE PEACE-KEEPING FORCE AUTOMATICALLY TO ANY NATION THAT NEEDS IT, AND TO SET UP WHATEVER PRINCIPLES AND PROCEDURES IT TAKES TO ESTABLISH AND MAINTAIN A WORLD WITHOUT WAR." There are two squares to be marked for YES or NO.

\*Operation Dismantle\* wants Canada to lead the way to a Peaceful World by making the Motion at the Fall Session of the United Nations Assembly that a World Referendum be undertaken to give the people of the world the opportunity to express their views on the crucial matter of TOTAL WORLD DISARMAMENT. Letters should be written to the Prime Minister requesting our U.N. Representatives to make such a Motion.

The Coalition for World Disarmament has a Petition available to hasten steps toward DISARMAMENT. It is headed, "AN APPEAL FOR ACTION ON DISARMAMENT IN THE INTERNATIONAL YEAR OF THE CHILD" and urges government to 1) pledge non-first use of Nuclear Weapons; 2) to agree on a comprehensive Test Ban; 3) to begin negotiations to prohibit research, production and deployment of new nuclear and other weapons of mass death and destruction; 4) to reduce stockpiles of nuclear bombs and their delivery systems

There are Movements afoot such as Women Strike for Disarmament, by withdrawal of services and consumerism, similar to a Strike for a Day.

The Tax Refusal Campaign will be well-publicized by Income Tax Time, 1980. The Literature on this matter advises, "When making out your income tax returns this year, let the Federal Government know of your displeasure at the percentage of our tax moneys being spent each year on armaments and related industries." There will be more on this in future editions of The Voice.

HISTORICAL Notes relating to the growth and activity of the Voice of Women since its inception in 1960, have been placed in the Archives at U.B.C. and are available for inspection on request. Included is a section of the Star Weekly Magazine, June 13/79, with an article entitled, "The United Nations Listened When Canadian Women Spoke", dealing with the International Co-operation Year as declared by the U.N.as a result of the dynamism of one, Helen Tucker, and the VOWs whom she represented and led.

This Year is the 50th Anniversary of the Recognition of WOMEN AS PERSONS in Canadian Law. Some women gathered in Toronto to discuss the formation of a Women's Political Party. Perhaps the time is not yet ripe, they thought, but did agree to seek out and support women candidates in future elections.
