The simplest form of a playgroup is a group of five parents-with-children who meet in one another's homes five times a week. One parent cares for all the children on Monday, a second on Tuesday, and so forth through the week.

Children of full-time working parents can also be in playgroups. The parent can either have a babysitter take the children each week or could take the group on the weekend. A group with several non-working parents could also invite a child of working parents to join without the parent taking a regular day.

Weekends -only playgroups, once - a - week playgroups, all-day or part-day playgroups: the variations are limited only by the needs & desires of the participants.....

participants Before this can happen, kids ¢ parents need to know each other. There is a need for a head quarters which will:-develop a file of parents ¢ kids who would like to form playgroups (including type of group, kid's ages, neighbor hood, etc.) - Keep a list of groups that are seeking new members.

-Organize playgroup workshops so that parents é others can share ideas for playgroups. - Provide services such as toy re-cycling, alending library of books about play activities, adirectory of where to

I would like to share with you the following letter I received from my mother recently. This was the first time she had really shared these kind of feelings with me, and i felt so good about it that I want to let everyone read the letter.

i would like to just add a note about her use of the word vulnerable. From the context of her letter she uses vulnerable to mean "at the mercy of her environment." I like to think of vulnerability as openness - a willingness to explore new and different ideas and feelings.

found so ha Tricia

"I would like to talk about a few things, give a few personal findings and share some experienced learnings.

I am a woman. I <u>have been</u> an infant female, a childish girl, a vulnerable menstrual female - and thank God - am now a woman! At (age) 53 this has come awfully late. I am no longer vulnerable! I love life. I love women. Vive la Womankind!

Being vulnerable is something I understand. I have suffered the tortured emotions: the shame, the guilt. the depressions and deviations. Vulnerability is the one weakness of womankind that is her worst enemy in her struggle to attain self esteem, equality and respect from those who put her down the most - MEN. We haven't time to be vulnerable. We can't afford to be vulnerable. The success in our lives, for happiness and fulfillment depends totally on Not being vulnerable. This is the enemy we must fight.

Whether it is poverty, insecurity, hearbreak, disappointments, losses or what - we must not allow ourselves to be vulnerable. If we are poor we must make ourselves wealthy in spirit by giving warmth and kindness to others not so spiritually well off as we are. If we are insecure we must trust God to co-ordinate our lives and we must learn to put things in their proper perspective - build our own daily routines and security - learn how to depend on ourselves - find and trust some good friends.

If we have losses (this happens to all of us) we are bound to have losses, some we can prevent - some not. Sometimes losses can be compensated. Sometimes they are blessings in disguise. Sometimes a beautiful memory.

Losses must be used to advantage. For example: Someone living a hum drum life may lose an arm only to find an unknown art gift and become a happy painter - living a full rich life at last with a real identity - a real security a real purpose. Another example: Someone loses a child or cannot have a child. Having one's own flesh and blood child is not necessarily a physical jov and in my opinion has no bearing on how much love you give or receive from a child (unless you suffer from self love and self pity - then

IUDs May Be Fatal

Are you wearing an IUD? If so, you may be in serious danger. Following is some of the recent information about the Dalkon Shield and on (opper IUDs recently marketed by G.D. Searle and Co. If you are affected in any way -PLEASE call us for legal and medical referrals. We MUST sue companies and doctors who are willing to use women's bodies as carelessly as is evidenced by the following information:

Below are quotes from Associated Press release from Washington.

"The Food and Drug Administration announced yesterday that up to 200,000 recently approved copper intrauterin devices - IUDs - are being withdrawn from the market, because of a risk of infections.

The FDA said the recall does not apply to another 100.000 of the devices which the manufacturer. G.D. Searle and Co. says may have already been inserted in females across the nation.

The agency said the Skokie. Illinois firm reported that it was recalling all of its new CU-7 devices after complaints from physicians that packages appeared to have defective seals and lacked assurance of sterility.

It was the first IUD product approved as a drug rather than a medical device, because it contains a small amount of copper which slowly leaches into a woman's uterus and provides additional protection against pregnancy in a manner not yet fully understood by scientists."

HAD ENOUGH ?? There's MORE ...

Following quotes from a form letter from Frederick M. Clark. Jr., M.D., Vice President and Medical Director, A.H. Robins Co. in Richmond, Virginia, to doctors. It is headed:

"Subject: Second Trimester Septic Abortion - Dalkon Shield

"Septic spontaneous abortion in the second trimester of pregnancy has been assumed to occur at a relatively low incidence rate, either with or without the presence of an IUD. Septicemia with septic shock is a serious and possibly fatal complication of an infected abortion.

Since marketing the Dalkon Shield late in 1970, the A.H. Robins Company has become aware of thirty-six cases of septic abortion, many mid-trimester timing, in patients purportedly wearing this IUD (an estimated 2,200,000 Dalkon Shields have been in use). Late in 1973, we were able to confirm that four of these cases resulted in maternal fatality; an additional similar fatal case, originally reported to have a shield. actually involved a bow-type intrauterine device. In the five fatal cases, abortions were alleged to have been spontaneous, occurred in the mid-trimester, and were not associated with uterine perforation. In three of these fatal cases, early symptoms were sore throat. 'flu, earache, and diarrhea, occurring about 24 to 48 hours prior to any sign of abortion. By the time abortion was threatened, the patients were critically ill. Of the other two cases, one presented with premature rupture of the membranes and one with slight vaginal bleeding.'"

We ask, sisters, how you would have known this, if we had not become aware of this letter that was addressed only to doctors. Birth Control: The Dalkon Shield

"Firm Warns Its IUD May Kill Mother, Child" "IUD Maker Plans Warning To Canadian MD's" and bagin ad of

These were the headings of 2 Globe and Mail articles, on May 30th and 31st, dealing with the Dalkon Shield intrauterine device. The American manufacturer and distributor, A.H. Robins, has reported that there have been 36 cases of septic abortions (death of the fetus due to poisoning, which occurs as a result of infection of the uterus lining) in women who became pregnant while fitted with the Dalkon Shield. Four of these resulted in the women and the infants' deaths. Most have occurred within the 4th, 5th and 6th months of pregnancy.

Since this information has been released, Planned Parenthood's U.S. national medical committee has instructed its clinics to stop prescribing the Dalkon Shield and to inform all patients to report for pregnancy tests if their menstrual periods are late.

- The company is sending letters to U.S. doctors advising that women who become pregnant should have the device removed, or 'if the pregnancy has proceeded beyond that point, then the woman should be offered the opportunity for a therapeutic abortion.'

- The company and the Canadian government are working on a letter to Canadian doctors. but changing the recommendations of the company to fit Canada's conservative abortion laws. They are NOT stopping the sale of the shield.

- Dr. Morrison, the assistant deputy minister of Health claims that the government is not going to take specific action against the company, or about doctors prescribing the shield, since there is no evidence of complications in Canadian women. This points out that:

1. Medical devices are not experimented with to prove safety before they are sold.

2. The government will agree to accept proof only after fatalities have occurred in (anada; somehow the government must assume that Canadians are genetically different from their American sisters, if the cases in the U.S. are not

Each mother and each baby start from point 1 - a family is created and love and attachment grow from there.

I had two children from my own womb but for years now I have been detached from any thinking connection between womb and love for my children. I really do not feel I had love for my babies till they were there before me. While in the womb it was merely a case of being pregnant - a condition of body and a promise of a baby. While waiting for an adopted baby I could have gone through less physical discomfort and still had the promise of a baby.

sufficient proof of the dangers of the shield. 3. There is no evidence that the devices don't work, because there is NO FOLLOW-UP requirement, no studies that HAVE to be done to show what the complications are, if they do exist. 4. 127,248 Dalkon Shields have been sold to Canadian women. The pregnancy rate is estimated at 4%. That means that at least 5,000 women will become pregnant while fitted with the IUD. What then? We have to face the decision of having an abortion or risking infection, spontaneous abortion, death of the fetus, of ourselves.

5. The Dalkon Shield sells for about \$6.75. That's \$859,000. if the cost is consistent across Canada. A.H. Robins has made lots of profits because of our desperate need for birth control, and because the government serves the owners and managers of the profit-making corporations, and not the consumers and workers.

Should they care whether the townhouses are rented to families with children?Mssrs.Doctor etal will have grossed twice that, not to mention that the value of the land from an investment viewpoint will have skyrocketed in 15 years.Should they care whether the children living there have adequate, safe play space?(Should I keep asking rhetorical questions?)

Who cares?One woman who lives there cares.She pays \$250 for the dubious pleasure of a small 2-bdrm. townhouse with thin walls and a management who dislikes children and threatens to evict her if "outside"children come to play with hers! Her children are all school aged and are occupied most of the day, but the parents of toddlers and preschoolers are supposed to keep them confined all day to the "approved" play area.this area consists a filled in swimming pool with 2 rusty,broken swing sets on top of it, alongside a filthy sandbox and some loose bricks. As she puts it, "When the kids are all in there, they are packed like sardines and all they do is fight and throw sand." So, she keeps the children busy with paper routes, courses at the"Y", etc., but always there is the threat of possible eviction hanging over her head, as if being a single parent with lively children isn't enoughl

There are at least 50 families with children in the apartment complex, many of them single parent families. The system which keeps power in the hands of the few with money is changing too slowly for people like these. Who cares?-obviously not enough people. Yet there is some consolation-her children might become the doctor, dentist and lawyer of the future and they might not forget!
