Jan 1994 :

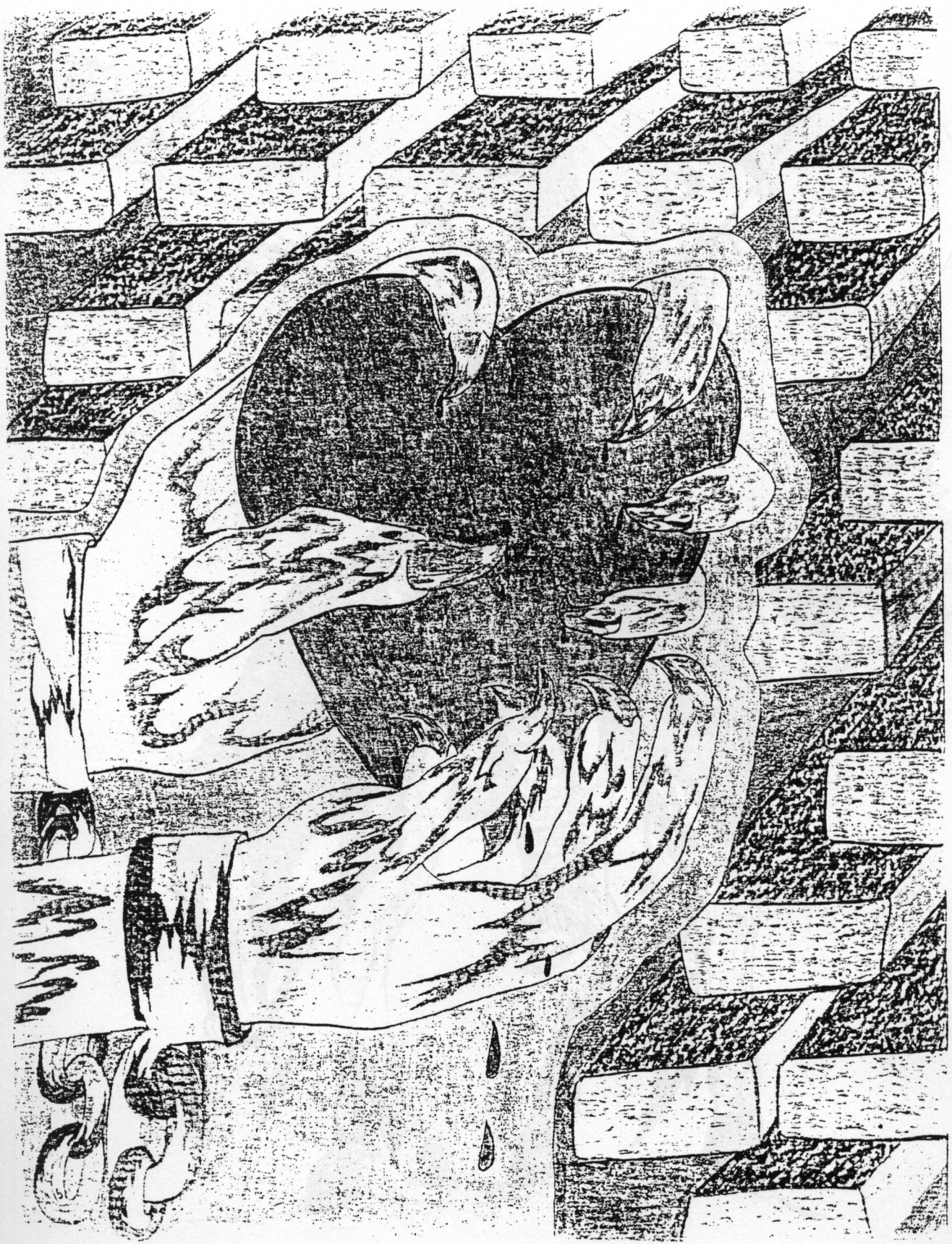
Hey mom, what's up?
